Company directors should be aware of recent changes to the law – which Forlin will discuss - which now allow for incidents of negligence to be aggregated, which in turn, can escalate the penalty to the level of imprisonment ranging from 18 months to seven years.

Other speakers include Maria Saraceni, barrister and board member, Jamie McPherson, Managing Partner, DWF Law, Dr Matthew Stewart, Jillian Hamilton, Managing Director at Managing Damage, and Hans Horst Konkolewsky, Secretary General of the International Social Security Association.

At this unique half -day event, international and national experts will explore safety governance and its impact on businesses, including their board members and operational leaders, and how to lead for positive fiscal outcomes and best practice.
